Whereas creation is a gift from God; and

Whereas God has called us to be stewards of God's creation; and

Whereas Jesus, Moses, Elijah, John the Baptist and numerous other key biblical personalities had many of their central experiences with God in the wilderness; and

Whereas this remains a common reality among God's human creatures to this day; and

Whereas all of God's Creatures have intrinsic value in God's eyes; and

Whereas our best scientific research tells us that non-human creatures are currently undergoing a crisis of extinction 1,000 times over rates typical of the planet's history; and

Whereas global warning is threatening to increase the rate of extinction; and

Whereas protecting the diversity of non-human life requires setting aside substantial, connected wilderness areas so the mobility necessary for adaptation to climate change and other threats is provided; and

Whereas humans depend upon a healthy environment for life giving services such as clean water and fresh air; and

Whereas many of these ecosystem services are approaching a state of crisis due to excessive human exploitation; and

Whereas many of the special places in the United States of America such as the red rock canyon lands of the Colorado Plateau, the coastal plain of the Arctic, and many other locations across the North American continent are threatened with harm due to excessive exploitation of resources and motorized recreation; and

Whereas the United States of America with its heritage of public lands and legal provisions for protecting wilderness lands provides a special opportunity to preserve the blessing of creation as God has given it to us; and

Whereas since the time of Theodore Roosevelt our federal government has legislated protective measures for wilderness area and millions of people have availed themselves of their spiritual and aesthetic benefits; and

Whereas The United Methodist Church through Resolution #10 in the 2004 Book of Resolutions states, "We advocate for the preservation of forests (including reforestation), wetlands and wild areas for ecological balance, wildlife production, water quality, air quality and the human spirit" and "we believe that the wondrous diversity of nature is a key part of God's plan for creation...we support national and international efforts to protect endangered species and imperiled habitats;"

Be it resolved that through its Conference Board of Church and Society the Illinois Great Rivers Conference (IGRC) of The United Methodist Church indicate to the members of the United States

Congress, the Department of the Interior, and the President its support for the protection of wilderness areas in our nation; and

Be it further resolved that the members and local churches of the IGRC are encouraged to indicate to their respective senators and congressional representatives their support for the protection of wilderness areas in our nation; and

Be it further resolved that the United Methodists of the IGRC are encouraged to visit and explore these special wilderness areas thereby availing themselves of the spiritual and physical blessings to be experienced in these expressions of God's creation.
